EMERGING VIETNAM

The Vietnamese economy has increased with 6.5 per cent in average the last 15 years. The purchasing power of the more than 90 million population has tripled in the same period, when looking at the development per capita.

Furthermore, the demand for foreign goods is high. Just looking at the latest five years, the imports of goods have increased with almost 15 per cent in average.

Looking ahead, the International Monetary Fund expects the economic growth to continue with the same speed. The purchasing power is expected to grow steadily together with the demand for imported products.

At the last PROPAK exhibition in March 2016, 73 per cent of the visitors had influence or a final say on purchasing for their business.

While 93 per cent of the visitors were satisfied with the PROPAK VIETNAM 2016, and 91 per cent of the visitors stated that they would like to attend the next PROPAK in 2017.
